## CORRESPONDENCE AND **COMMUNICATIONS** Emily Lambe included the April calendars in the Board Packet, noting lots of activities planned for Spring **Trustee Connection** Break. Jared Olar updated the Board on his work with the Pekin Bicentennial activities, including a film **Upcoming Programs** series at the library, a weekly column of Pekin History, a Bicentennial book, and downtown business building history. FINANCIAL REPORT AND Following discussion, Trustee Gillis MOVED to APPROVE expenditures for February in the amount of **EXPENDITURE APPROVAL** \$110,342.71. Trustee Williams SECONDED the MOTION. On roll call vote, Trustees Sours, Turner, Williams, Leitner, Naughtin, Allen, Crowell, Gillis, and Ladendorf voted aye. There were no nays. MOTION was PASSED. **COMMITTEE REPORTS** Trustee Leitner updated the Board on the Personnel Committee, stating the link to the Director's Review will be emailed in a few days, and there will be a joint Personnel and Finance Committee meeting on April 16. **DIRECTOR'S REPORT** Director Brooks gave an update on the Pekin Grade-Level Readiness Coalition (formerly Literacy Summit). The group has met three times, and their goal is to have 90% of kids in Pekin reading at the proficient level by the end of third grade by 2033. Their key strategy areas are school readiness, school attendance, afterschool and summer learning, and book distribution. **UNFINISHED BUSINESS** None.

## NEW BUSINESS

Sign Intergovernmental Agreement Establishing RSA and Authorizing Membership in RSA Trustee Crowell MOVED to APPROVE to sign the Intergovernmental Agreement Establishing RSA and Authorizing Membership in RSA. Trustee Williams SECONDED the MOTION. Director Brooks gave the history and data of RSA and how it provides the library's online catalog access. On voice vote, all present voted aye. There were no nays. MOTION was PASSED.

Continue Participation in the Non-Resident Card Program, including Waiving Fees for Minors Under 18	Trustee Naughtin MOVED to APPROVE to Continue Participation in the Non-Resident Card Program, including Waiving Fees for Minors Under 18. Trustee Gillis SECONDED the MOTION. Director Brooks explained a new law in May of 2022 that gives the library the option of including free non-resident cards to minors. Currently, there has been a gap from the 0-5 years age group since they don't qualify for student cards, and this would solve this issue. On voice vote, all present voted aye. There were no nays. MOTION was PASSED.
Amend Minutes from the September 26, 2023 Board Meeting	Trustee Leitner MOVED to APPROVE to Amend the Minutes of the September 26, 2023 Board Meeting. Trustee Williams SECONDED the MOTION. Director Brooks would like the minutes of the September 26, 2023, Board Meeting to reflect the Director's Memo and in the recording to say, 'The recommendation is to transfer \$91,731 into our Capital Development funds with the first \$5,000 going into the Technology Fund.' On voice vote, all present voted aye. There were no nays. MOTION was PASSED.
Review Strategic Plan Update	The Library Board went over the current Strategic Plan in the board packet, with updates listed under each action.
OTHER BUSINESS	The Library Board talked about the increase of homeless patrons at the library. Director Brooks informed the Board that the City of Pekin's Public Works Department will now be mowing the library's property. Director Brooks also distributed information on openings for the RAILS Board of Trustee seats.
ADJOURNMENT	Trustee Gillis MOVED to adjourn at 6:29 p.m. Trustee Williams SECONDED the MOTION. On voice vote, all present voted aye. There were no nays. MOTION was PASSED.
